

## GRANT APPLICATION FOR SCHOOL VISITS TO MACKINAC STATE HISTORIC PARKS

- Grantees must visit at least 2 MSHP sites during their trip or participate in one immersive experience
- Grant applications must be received no less than 30 days before date of the trip
- Grant funds will be sent to school prior to trip
- School is responsible for paying costs such as site admission directly
